Tobacco Citation Instructions

A person cited under section [569.11](#), Florida Statutes, must comply with one of the following three options for a first violation after 12 weeks of any other violation.

Option 1 – Contest the citation by contacting the Clerk of the Court at one of the below listed locations to complete a request for hearing. This request must be in writing and must include your name, mailing address, and case number.

Option 2 – Complete a county school approved anti-tobacco program and mail completed form along with \$30.00 fine (check or money order made payable to “Clerk of Court) to: **P.O. Box 6043, DeLand, FL 32721-6043**. Clearly print your name, mailing address, and case number on any correspondence with the Clerk’s Office to ensure proper processing. (**Note: You must bring a copy of the citation to the class**)

Option 3 – Complete a county school approved anti-tobacco program and complete 16 hours of community service at an approved community service program. Mail both the county approved completion form and approved community service completion for to the Clerk of the Court at one of the addresses listed above. Clearly print your name, mailing address, and case number on any correspondence with the Clerk’s Office to ensure proper processing. You have thirty (30) days from the date of the issuance of the citation to comply. (**Note: You must bring a copy of the citation to the class**)

TO OBTAIN INFORMATION FOR COUNTY SCHOOL APPROVED ANTI-TOBACCO PROGRAMS AND/OR LIST OF [APPROVED COMMUNITY SERVICE PROGRAMS](#) IN YOUR AREA, CALL THE VOLUSIA COUNTY HEALTH DEPARTMENT, OFFICE OF HEALTH AWARENESS AND TOBACCO, AT (386) 274-0603.

FAILURE TO COMPLY WITHIN THIRTY (30) DAYS OF THE ISSUANCE OF THE CITATION MAY RESULT ON THE COURT ISSUING AN “ORDER TO SHOW CAUSE”, AND SETTING THE MATTER FOR A HEARING. FAILURE TO ATTEND THE SCHEDULED HEARING MAY RESULT IN SUSPENSION OR WITHHOLDING OF ISSUANCE OF YOUR DRIVER LICENSE.

*****For a second violation within 12 weeks of the first citation you must pay a \$30.00 fine to the Clerk of the Court at one of the locations within thirty(30) days of the citation being issue.*****

*****For a third or subsequent violation within 12 weeks of the first violation, the court will direct the Department of Highway Safety and Motor Vehicles to withhold issuance of or suspend your driving privilege as provided by section [322.056](#), Florida Statutes.*****

Note to Officers: Please obtain a valid mailing address for the defendant and document in the narrative portion of the citation that the defendant was given a copy of these instructions. You may not list an criminal offense on the same 798 or 707 used to cite for a violation of section [569.11](#), Florida Statutes. Tobacco citations may not be issued on Uniform Traffic Citation.
