



2006 Tuberculosis Fact Sheet, Duval County

In 2006, Duval County ranked 3rd for tuberculosis morbidity in Florida.

- 8% (88/1,038) of Florida's TB cases in 2006 resided in Duval County
- 20% (18/88) of TB cases were co-infected with HIV
- 22% (19/88) of TB cases were in the foreign-born population
- 13% (11/88) of TB cases reported excessive use of alcohol within the past year
- 17% (15/88) of TB cases reported drug use within the past year
- 2% (2/88) of TB cases were among the homeless

Gender:

Males represented 61% (54/88) of all Duval County's TB cases.

- 24% (13/54) of males were 25-44 years of age
- 19% (10/54) of males were non-Hispanic White
- 6% (3/54) of males were Asian
- 65% (35/54) of males were non-Hispanic Black
- 11% (6/54) of males were Hispanic (all races)

Age-Group:

Ages 25-44 reflected 30% (26/88) of Duval County's TB morbidity.

- 50% (9/18) of HIV/TB co-infections were 25-44 years old
- 21% (4/19) of foreign-born TB cases and 32% (22/69) of U.S.-born TB cases were 25-44 years of age

Race/Ethnicity:

Non-Hispanic Blacks represented 64% (56/88) of TB cases in Duval County.

- 34% (19/56) of TB cases in Blacks were 25-44 years of age
- 63% (35/56) of TB cases in Blacks were male
- 29% (10/35) of TB cases in Black males were age 25-44
- 89% (16/18) of all TB/HIV cases were among Blacks
- 29% (16/56) of TB cases among Blacks were co-infected with HIV
- 20% (7/35) of TB cases among Black males were HIV positive

Hispanics (all races) represented 7% (6/88) of Duval County's 2006 TB cases.

- 0% (0/6) of TB cases in Hispanics were 25-44 years of age
- 100% (6/6) of TB cases in Hispanics were male
- 0% (0/6) of TB cases among Hispanic males were age 25-44
- 0% (0/18) of all TB/HIV cases were among Hispanics
- 0% (0/6) of TB cases among Hispanics were co-infected with HIV
- 0% (0/6) of TB cases among Hispanic males were HIV positive
