2006 Tuberculosis Fact Sheet, Hillsborough County

In 2006, Hillsborough County ranked 4th for tuberculosis morbidity in Florida.

- 8% (83/1,038) of Florida's TB cases in 2006 resided in Hillsborough County
- 18% (15/83) of TB cases were co-infected with HIV
- 46% (38/83) of TB cases were in the foreign-born population
- 19% (16/83) of TB cases reported excessive use of alcohol within the past year
- 14% (12/83) of TB cases reported drug use within the past year
- 14% (12/83) of TB cases were among the homeless

Gender:

Males represented 70% (58/83) of all Hillsborough County's TB cases.

- 43% (25/58) of males were 25-44 years of age
- 31% (18/58) of males were non-Hispanic White
- 9% (5/58) of males were Asian
- 26% (15/58) of males were non-Hispanic Black
- 34% (20/58) of males were Hispanic (all races)

Age-Group:

Ages 25-44 reflected 43% (36/83) of Hillsborough County's TB morbidity.

- 53% (8/15) of HIV/TB co-infections were 25-44 years old
- 58% (22/38) of foreign-born TB cases and 31% (14/45) of U.S.-born TB cases were 25-44 years of age

Race/Ethnicity:

Non-Hispanic Blacks represented 25% (21/83) of TB cases in Hillsborough County.

- 33% (7/21) of TB cases in Blacks were 25-44 years in age
- 71% (15/21) of TB cases in Blacks were male
- 33% (5/15) of TB cases in Black males were age 25-44
- 33% (5/15) of all TB/HIV cases were among Blacks
- 24% (5/21) of TB cases among Blacks were co-infected with HIV
- 33% (5/15) of TB cases among Black males were HIV positive

Hispanics (all races) represented 37% (31/83) of Hillsborough County's 2006 TB cases.

- 52% (16/31) of TB cases in Hispanics were 25-44 years of age
- 65% (20/31) of TB cases in Hispanics were male
- 65% (13/20) of TB cases among Hispanic males were age 25-44
- 53% (8/15) of all TB/HIV cases were among Hispanics
- 26% (8/31) of TB cases among Hispanics were co-infected with HIV
- 25% (5/20) of TB cases among Hispanic males HIV were positive
