FLORIDA STATE SURGEON GENERAL 2009-2010 HEALTH INNOVATION PREVENTION AND MANAGEMENT AWARDS

Purpose:

The purpose is to recognize organizations, businesses or programs that have developed innovative and creative ways of addressing growing health concerns in their local environment (for example; among members, employees and/or community). The First Annual Florida State Surgeon General 2009-2010 Health Innovation Prevention and Management Awards will recognize the winner's in their community.

The awards will provide an opportunity to increase public awareness of the winner's creative approaches in addressing rising healthcare concerns in their environment.

Eligibility:

Organizations, businesses, or programs that have received federal or state funding are eligible to apply, as long as the full responsibility and development is not that of the federal or state funding sources. Also, the organization, business, or program must be in operation for at least two years and address at least one of the following risk factors:

- Nutrition
- Obesity
- Physical Activity
- Access to Healthcare
- Chronic Disease

Categories:

Please select one category listed below that would best describe the organization, business, or program applying for the award.

- **Faith-Based and/or Community-based Initiatives**
Faith-based and/or community-based Initiative that supports chronic disease and/or health promotion in at least one of the risk factors (nutrition, obesity, physical activity, access to healthcare and/or chronic disease).
- **Health Care Delivery**
Organization, business, or program involved in the provision of services and/or technologies directly related to healthcare services that support chronic disease and/or health promotion programs in at least one of the risk factors (nutrition, obesity, physical activity, access to healthcare and/or chronic disease).
- **Healthy Workplace, Large Employer (500 or more employees)**
Organization, business, or program that supports a worksite chronic disease prevention and/or health promotion program in at least one of the risk factors (nutrition, obesity, physical activity, access to healthcare and/or chronic disease) that has 500 or *more* total number of domestic employees.

INSTRUCTIONS

- **Healthy Workplace, Small Employer (less than 500 employees)**
Organization, business, or program that supports a worksite chronic disease prevention and/or health promotion program in at least one of the risk factors (nutrition, obesity, physical activity, access to healthcare and/or chronic disease) that has *less* than 500 total numbers of domestic employees.
- **Public Sector**
Programs that have received federal and state funding are eligible for nomination provided that a non-Federal agency/organization has full responsibility and authority for developing and implementing the program. A local, county, state, territorial, or tribal government-based/funded entity that supports a chronic disease prevention and/or health promotion program in at least one of the risk categories cited in the announcement.
- **Schools (K-12)**
Primary and secondary education-based/originated entities that support a chronic disease prevention and/or health promotion program in at least one of the risk categories cited in the announcement.
- **Military Support Initiatives**
Organizations, businesses, or programs that provides healthcare or promotes wellness to our military troops/ services at home or overseas.
